The Mandal Educational Officer, Ongole has verified the application for Provisional Recognition with reference to the conditions laid down in the previous orders and G.O.Ms.No. 1 Edn. Dt 01-01-1994 and subsequent amendments issued by Government and submitted proposal in the reference 3rd cited. After examination of the proposals submitted by the Mandal Educational Officer in the reference 3rd cited, Provisional Recognition is hereby accorded for a period of 10 years commencing from the academic year from 2017-18 to 2026-2027 for classes from I to VII (EM) to NEXTGEN INTERNATIONAL SCHOOL, KOPPOLE, ONGOLE, Prakasam Dist subject to fulfillment of the following conditions.

- 1. That the society shall abide by the instructions/rules and regulations made by the Government or authorized officer from the time to time.
- 2. That the Educational Institution shall serve the needs the locality more particularly.
- 3. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 4. That the school timings vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
- 6. That the results of Institution shall be satisfactory every year.
- 7. That the records/ accounts/audit report shall be furnished to the District Educational Officer, every year by 30th September at least.
- 8. That the list of Governing Body shall be furnished to the District Educational Officer, every year.
- 9. That the pay structure/fee structured fixed by the Governing Body shall be got approved by the District Educational Officer in June every year.
- 10. That all the conditions prescribed in the G.O.s and other orders Which are specified in this order shall be complied with.
- 11. That the school shall not be closed without giving notice both to the parents/ District Educational Officer, and competent authority at least six months before.
- 12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
- 13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the present recognition.
- 14. That the society shall provide fire safety measures in the school as per the No objection certificate.
- 15. That the society shall renew the Fire NOC in time every year and submit renewed copy of NOC every year.
- 16. The management is informed that no thatched room accommodation is allowed to run the school.

- 17. Proper and adequate sanitation facility should be provided for students especially for girl students.
- 18. Proper and adequate safety measure shall be taken for children within the school campus and also near the school premises.
- 19. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.

- 24. That the management shall take every responsibility for the timely safety and comfortable mobility of the School Children from the residences and School and vice versa.
- 25. That the school Van/Bus should be ensured road worthy for the transportation/mobility of School Children.
- 26. That the School Bus should be free from all taxes due and should be maintained with regular checks by authorized mechanism of periodically/ as and when required without causing any sort of dislocation for the School Children opting the bus facility.
- 27. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the School Van/Bus.
- 28. That the management shall ensure the vehicle and safety grills be provided to the windows of the Vehicle.
- 29. That the management shall ensure the Accounts of the School audited by an Authorised Chartered Accountant every year and submit before 30th September of every year.
- 30. The management shall have to follow the rules and guidelines issued to G.O.Ms No. 91 Edn. Dated 06-08-2009.
- 31. That the management should scrupulously follow the provisions of RTE Act, 2009.
- 32. - 13. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e, at least 6 months prior to the date of expiry of the renewal.
- 14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
